



## PRESIDENT'S MESSAGE

I hope most of our members have enjoyed their summers more than those few of us in Edmonton have, where we have been plagued by cool rainy weather until these past 2 weeks. As the days get noticeably shorter, we face the depressing reality that winter is just around the corner.



Of course, that also means that we are fast approaching our Annual Scientific Meeting in Quebec City from October 20-23, and I am looking forward to the excellent meeting Dr. Richard Warrington has assembled as Program Chair.

This meeting will mark the end of my first year as President of our Society, so it seems appropriate now to update you on the various projects your Board of Directors have been addressing since the Victoria meeting.

Last fall and winter, we were deeply involved in discussions with the Government of Canada regarding their proposed changes to food labeling, which were finally passed into law, coming into effect last month. The changes should make it easier for our food-allergic patients to read labels and more successfully avoid the most common and problematic priority allergens.

We were also busy helping Air Canada establish their policy in response to Transport Canada's decision to rule peanut allergy a formal disability. Obviously, it is hard to craft a policy that will please everyone, especially given the lack of firm science in the area, however in the end I think Air Canada did a reasonable job balancing the convenience of its staff and passengers with the safety of its peanut-allergic clientele.

On a somewhat related note, the CSACI and particularly Drs. Don Stark and Richard Warrington have long been campaigning for Air Canada to reconsider its unfortunate decision to allow furred pets to be transported in the passenger cabin. Hopefully the recent decision by the Canadian Medical Association to also adopt this position will help apply the necessary public pressure.

The Society, and particularly the Pediatric Section, have also been busy reviewing proposed changes to Health Canada's infant feeding guidelines, and we trust our suggestions will be incorporated into their final documents. Additionally, the CSACI has partnered with HealthLink BC to update their excellent document addressing current strategies for reducing allergic risk for infants.

In an ongoing partnership between CSACI, Anaphylaxis Canada, and Leap Learning Technologies, we were excited to see the e-learning Anaphylaxis Readiness Course recently launched in the US, an excellent program developed with the scientific input of several of our members (<http://allergyready.com/expert-team/>).

The Society has also been campaigning against the decision by Gamma Dynacare in Ontario to offer food-specific IgG testing directly to consumers. We are also encouraging the College of Physicians and Surgeons of Ontario to adopt a more appropriate and evidence-based policy towards unproven alternative (non-allopathic) healthcare approaches, as their proposed draft policy is woefully inadequate.

Finally, the CSACI has agreed to partner with the Canadian Thoracic Society, AllerGen, and the Canadian Lung Association to name a few in hosting the World Asthma Congress in Quebec City in August 2012. We have also entered a preliminary bid to cohost the 2017 World Allergy Organization meeting in Montreal, and we will definitely keep you posted as these exciting events play out.

## ASTHMA REPORT

### GOALS FOR 2011

1. Reposition CSACI as a partner with the CTS in the generation of asthma guidelines. No or very little CSACI presence in recent iterations of Canadian asthma guidelines.
2. Form a group within CSACI to elaborate asthma guidelines for children < 6 years of age. The most recent CTS guideline excludes children under 6. Unless CSACI becomes a partner with CTS, CSACI should consider producing a guideline for that age group.
3. Write and publish a guide for primary care on the management of preschool wheezing. In the short term, the section will write a brief article to serve as a guide to primary care practitioners dealing with young children on management of preschool wheezing up to step 2. The focus of the article is to generate a written action plan.

### PROGRESS TO DATE

1. After several approaches by several Board members to engage with the CTS in the asthma guidelines committee and a response from the CTS expressing a desire for collaboration, no formal activities have developed concerning participation in the asthma guidelines process. Nevertheless, the CSACI has been invited to participate in the CTS Pan-Canadian Respiratory Standards Initiative for Electronic Medical Records (PRESTINE Project) in September.
2. Due to personal circumstances, Dr. Noya has had to postpone action on this objective.
3. Due to the same reason, Dr. Noya has delayed the drafting of this guide to the winter of 2012.

### ACTIVITIES FOR THE 2011 ANNUAL MEETING

1. During the Asthma Section meeting, Dr. Noya will present two important and provocative trials: inhaled corticosteroids as rescue treatment in mild persistent pediatric asthma and maintenance versus intermittent corticosteroids in preschool wheezing.  
-FD Martinez et al. *Use of beclomethasone dipropionate as rescue treatment for children with mild persistent asthma (TREXA): a randomized, double-blind, placebo-controlled trial.* Lancet 2011; 377:650-7.  
-Zeiger RS et al. *Maintenance vs. intermittent inhaled steroids in wheezing toddlers (MIST Protocol).* Presented at the 2011 annual meeting of the AAAAI, San Francisco.  
Dr. Kim will discuss the upcoming ACAAI asthma review and compare it with the CTS current recommendations.
2. Dr Kim and Dr. Noya will co-moderate the asthma plenary session on the morning of Sunday, October 23. The program includes a presentation of vitamin D in asthma and another on perfumes and airway symptoms.
