This month has been designated as Food Allergy Awareness month by the House of Commons, through the hard work of Anaphylaxis Canada. We congratulate AC and Sara Shannon for their efforts on behalf of all food allergic patients.



The Society, in association with Anaphylaxis Canada, Association québécoise des allergies alimentaires, Allergy/Asthma Information Association and Allergic Living Magazine has spent considerable time in discussions with WestJet regarding their policies regarding food allergic patients and pet allergic patients and we are close to a joint review of WestJet's policy which we hope will be a helpful guide to them in the future. We commend WestJet on their willingness to participate in these discussions.

The Society has received an offer from the WAO regarding the possibility of jointly organizing a North American Meeting of the organization in 2017. Many of our members will remember the 2003 meeting in Vancouver. ANAPHYLAXIS CANADA WELCOMES PARLIAMENT'S DECLARATION OF MAY AS FOOD ALLERGY AWARENESS MONTH

Anaphylaxis Canada applauds Parliament's motion recognizing Food Allergy Awareness Month and will be commemorating the occasion by promoting a number of initiatives intended to support the 1.3 million Canadians who live with food allergies. This is the first year such a month has been designated in Canada and will now be a permanently recognized occasion. Several other countries including the US, UK, Italy, New Zealand and Australia have similar declarations. "The declaration of Food Allergy Awareness Month is a significant step in the ongoing effort to educate the public about food allergies," said Laurie Harada, Executive Director of Anaphylaxis Canada.

Anaphylaxis Canada will be recognizing Food Allergy Awareness Month through a number of planned initiatives and events. Anaphylaxis Canada will also be launching two key initiatives for teens and young adults: a new French version of its website especially created for allergic teens to help them manage their food allergies more effectively; and the Sabrina Shannon Memorial Award for youth involvement in community anaphylaxis education. The award is dedicated to the life of Sabrina Shannon.

AllerGen Emerging Clinician-Scientist Research Fellowship

AllerGen NCE Inc., the Allergy, Genes and Environment Network (AllerGen), a national research network, is pleased to announce the launch of a national competition for an Emerging Clinician-Scientist Research Fellowship valued at \$250,000 over two years. The goal of the AllerGen Emerging Clinician-Scientist Research Fellowship is to enable Canadian Clinical Immunologists and Allergists to pursue allergy, asthma and/or anaphylaxis academic research training immediately following their Clinical Immunology and Allergy sub-specialty training in order to:

- Strengthen the academic capacity of Canadian Clinical Immunology and Allergy subspecialists
- Increase Canadian capacity for translational Clinical Immunology and Allergy research
- Facilitate enhanced patient care through excellence in basic and clinical Allergy and related immune disease research

Eligible candidates are Canadian citizens or permanent residents who are clinicians that have completed Clinical Immunology and Allergy sub-specialty training within the past 18 months at an academic health sciences centre. Preference will be given to applicants whose host institution can confirm that the applicant has been identified for a junior faculty position following successful completion of the fellowship.

Full applications must be either hand-delivered or courier stamped no later than: Friday, October 1, 2010 by 12:00 p.m. EST.
